Some Post still needs to add Community Service Reports each month or as they complete them so that they don't have to dump it on the Jr. Vice Commanders at the last minute. Remember that our Community Service reports are used to help us as a Dept to receive our grant money. At the end of each month, The JVC has to turn in the numbers for that month of our Veteran Community Service reports for that month. Some of you still wait until the next month to input information. Example. Post A has been submitting its Community Service Reports for the month of February. They completed a total of 12 Vet Projects, 24 hours, and 254 miles. Great that information can not be counted in the Report that the JVC turns in. Next Example, Post B put in none of their Veteran Service Projects they did in February but waited until 5 March to input the

information for February. Because the EOM report has been turned in at the end of February for all Veteran Service Projects by all Post in the Dept, Post B's information will never count or help us because it was inputted into the system in March. This is why we ask all Posts to input your Community Service reports as they are conducted or before the month ends so that it will count for that month.

I want to thank everyone for the support not only as your JVC but ever since I became a Post Commander in 2013. I have enjoyed making new friends and helping others become members and leaders in the VFW. 2020 Department Elections

Section 516 of our National By-laws and Manual of Procedure states, in part: (a) The elective officers of each Department shall be a Commander, Senior Vice Commander, Junior Vice Commander, Quartermaster, Judge Advocate, Surgeon and Chaplain.

In addition to those offices required by our National By-laws to be elected at our annual Department Convention, we will also be electing one 5 year member of the VFW Endowment Association, one 3 year member of the Board of Directors for the Convention Corporation and one 5 year member for the Veterans Service Committee.

Department elections will be held at the State Convention in Manhattan on Sunday, June 14, 2020.

Delegate voting strength of a Post is determined by one delegate for each thirty members or fraction thereof in good standing in the Post as of the end of April 2020. Additionally, Past Commanders-in-Chief, National Council Members, the Department Commander, all Past Department Commanders (who are members in good standing of Posts within the Department), all elected officers of the Department, the Chief of Staff, the Inspector, all District Commanders and all Post Commanders, shall be entitled to one vote. Any individual possessing more than one qualification to vote at the Department Convention shall have no more than one vote.

Any Post in arrears for National or Department dues, poppy money, supply money, or other financial obligations, failing to have their Quartermaster properly bonded in accordance with Section 703 of the National By-Laws, failing to ensure the Post is properly insured in accordance with Section 709 or failing to submit properly completed quarterly Post Trustees Report of Audit or Post Election Report shall be deprived of all representation at Department Conventions. Such representation shall be restored promptly upon proper adjustment of such deficiencies.

The following officers are elected positions to be filled.

Commander Senior Vice Commander Junior Vice Commander Quartermaster Judge Advocate Surgeon Chaplain Convention Corporation – 3 year Endowment Association – 5 year Veterans Service Committee – 5 year National Council Member
