

Also you may report your Hospital activates on you Community Service report now. National is mandating that Post must increase their

Community Service 10% over last year to qualify for All-American.

All Post need to assure that your Post Adjutant logs into the National website to enter your respective activities for Nationals All-American program on the All-American Dashboard. The Post Adjutant is required to enter verification on the Post Social Page, Partnering Events, Action Corp, Voice of Democracy, and Patriots Pen activities.

Congratulations to all the Post that are 100% in membership. Your hard work is paying off. There are many Post in the State that are 10 or less in achieving 100%. Now is the time to work the membership. Your reinstates is the place to start. Currently at this writing Kansas is 13<sup>th</sup> in the nation regarding all the other Departments. 












#### State Sr. Vice Commander


Comrades and Auxiliary Members,



There are Posts that have missing audits and bonds. I encourage each Post and District to submit audits on time.

IRS Form 990 filings for taxes are due on the 15th day of 5th month after the end of your tax year. For most posts in the state that would be December 31st making your tax filings due NLT May 15, 2020.

Every post is required to file a Form 990 regardless of income. Minimum income exclusions are no longer recognized by the IRS due to change in laws and internal regulations over the past few years. At a minimum file the "post card" type 990.

The District Inspectors along with myself are here to provide assistance, training, and support. Please reach out if we can assist you or answer any questions.

# Duane Sarmiento Junior Vice Commander-in-Chief Veterans of Foreign Wars of the United States

Duane Sarmiento was elected Junior Vice Commander-in-Chief of the Veterans of Foreign Wars of the U.S. on Aug. 3, 2021, at the 122nd VFW National Convention in Kansas City, Missouri.

He served in the United States Navy from 1988 to 1997, and the United States Naval Reserve from 2002 to 2006, earning his VFW eligibility by serving in Operations Desert Shield/Storm. In recognition of his service, he received the Navy Achievement Medal, Navy Combat Action Ribbon, Navy Good Conduct Medal, the Southwest Asia Service Medal with three campaign stars, the Saudi Arabian Medal for the Liberation of Kuwait, Kuwait Medal for the Liberation of Kuwait and numerous other medals and ribbons. In 2003, he earned the title of the Naval Reserve Center Sailor of the Year at Fort Dix.

Duane joined the VFW in 1990 at Post 5579 in Gibbstown, New Jersey, where he maintains his Gold Legacy Life membership. He has served in elected and appointed positions at the Post, District and Department levels,



culminating with his election as the VFW Department of New Jersey Commander from 2018 to 2019. On the national level, he has served on the National Security and Foreign Affairs Committee, General Resolutions Committee, as Special Aide-De-Camp, and as Inspector General from 2019 to 2020.

He retired as a police officer with the Greenwich Township Police Department and Gloucester County Sheriff's Department in New Jersey. Duane was the director of Veterans Affairs in Gloucester County, New Jersey, retiring after 10 years of services.

He is also a member of the Fleet Reserve Association, Branch 57.

Duane and his wife, Ellen, reside in Gibbstown, New Jersey.

MISSION "To transport Kansas veterans who served our country during WWII, the Korean War, and the Vietnam War to Washington, D.C. to visit the Memorials that commemorate their service to our country at no cost to the veteran".



There has been a total of 73 flights that have provided the opportunity for over 2300 of our veterans to visit our nation's capital.

The opportunity for this memorable experience is made possible by a grateful public and a large group of volunteers. There are no tax dollars involved. Financial contributions come from many sources: civic groups, military organizations, students, churches, businesses, and individuals.

Some of our aging veterans need assistance to have a safe and comfortable experience. Guardians or helpers travel with the veterans to assist in any way needed. These guardians make a tax-deductible contribution that covers all of their travel expenses, lodging, and meals. While some of the guardians may be family members or friends, some are willing to help serve to help a total stranger.

Priority is given to the older WW II veterans, then the Korean War veterans, and then the Vietnam War veterans. For each war era, the veterans are called in the order that they've submitted their applications.

With a waiting list of over 700 deserving veterans patiently waiting, the program needs the continued support of the public and the efforts of the many volunteers.
